#### INSTRUCTIONS FOR COMPLETION OF PROXY FORM

#### 1. Appointment of Proxy

If you wish to appoint the Chairperson of the Meeting as your proxy, mark the box. If the person you wish to appoint as your proxy is someone other than the Chairperson of the Meeting, write the name of that person. If you leave this section blank or your named proxy does not attend the Meeting, the Chairperson of the Meeting will be your proxy. A proxy does not need to be a voting member of Spinal Cord Injuries Australia (Company).

### 2. Voting directions to your Proxy

You may direct your proxy how to vote on an item of business by placing a mark in one of the three boxes opposite that item of business. If you do not mark any of the boxes on a given item, your proxy may decide whether or how to vote on that item. If you mark more than one box on an item, your vote on that item will be invalid.

#### 3. Signature of Voting Member

To appoint a proxy, you must be a voting member of the Company and must sign this form.

#### 4. Lodgement of Proxy
